The TBT Collectibles Show: SHOW RULES, POLICIES, PROCEDURES

1. Applicants for table space must be at least 18 years old. Applicants under age 18 must have a parent or legal guardian sign the signature portion of this application.
2. Refunds will only be made on booth cancellations if the booth is re-sold by The Temple B’Nai Torah. No refunds will be made on any cancellation received during the thirty (30) calendar days immediately before the show dates (including for weather-related reasons.) A cancellation made at any time will be subject to a \$100.00 fee to the registered dealer.
3. The Temple B’Nai Torah will not be liable for full or partial booth refunds due to the cancellation of the show for all reasons or circumstances not caused by The Temple B’Nai Torah, or the relocation of the show to another facility and/or geographic location in an emergency where the original site becomes unavailable.
4. A booth reservation entitles the dealer to 1 free badge per Table. However, The Temple B’Nai Torah will provide only the number of admission badges corresponding to the approved names of booth assistants provided to The Temple B’Nai Torah. Those to whom badges are provided are expected to be legitimate booth assistants. All other members of the dealer’s party are admitted only during public hours, after paying full admission fees. Unauthorized transfer of badges will be grounds for expulsion of both parties, without refund. Additional badges are available to show dealers only for \$3.00 per badge with a maximum of 2 per dealer. The names must be provided and payment for the badges must be included when the badge list is requested. Show management reserves the right to refuse any proposed badge holder.
5. The registered dealer is expected to be represented throughout the full show hours. The registered dealer may not send a surrogate. Only the registered dealer and valid employees will be acceptable in the booth mentioned above. Any policy violation will void this contract, with The Temple B’Nai Torah permitted to re-assign the booth space without refunding the registered dealer. The names of all persons who will assist the dealer must be on record with The Temple B’Nai Torah before the show dates. Only persons registered with The Temple B’Nai Torah will be permitted behind a dealer booth. Dealer badges are provided by The Temple B’Nai Torah and are to be worn at all times inside the show facility. Badges may not be transferred for any reason.
6. The re-sale or transfer of booths is not permitted and will not be honored by The Temple B’Nai Torah.
7. The Temple B’Nai Torah will permit only dealers of record for this show to sell inside or outside the facility. Anyone found illegally selling on the property will be subject to removal from the property and/or prosecution. Booth “sharing” is not permitted without prior written approval by The Temple B’Nai Torah.
8. Dealers are expected to be neatly dressed, groomed, and carry themselves in a manner that reflects positively on this show, the general public, fellow dealers, and this industry. Dealers are expected to keep their booth area neat and free of trash and refuse. Only dealer-related handouts are permitted inside or outside the show facility. No barking or amplification systems by the dealer are permitted. Violation of any rules may be cause for the immediate removal of the offender from the show without prior warning or refund.
9. All booths must be staffed and ready for business by the designated time at which the show is open to the public. **ALL EXHIBITOR BOOTHS MUST REMAIN OPEN FOR BUSINESS THROUGH THE PUBLIC SHOW HOURS.** This policy will be strictly enforced. No packing of merchandise or “booth breakdown preparation” may occur until 30 MINUTES before the show closes on Sunday at 3:00 PM. This is mandatory. Failure to adhere to this policy will result in the following:
 - 1st Offense – Verbal warning
 - 2nd Offense – Written warning

3rd Offense – Expulsion from show

10. Each dealer is responsible for complying with all federal, state, and local laws, including those regarding required tax licenses and payments. Dealers must display a valid New York Sales tax license at their booth.
11. Anyone selling, displaying, or trading in reprinted material, not marked or represented as such, or dealing in or displaying forged, counterfeit, misrepresented, and/or stolen merchandise will be subject to removal from the show facility, confiscation of said material, and the fullest prosecution of the law without any prior warning. The dealer is responsible for the validity of his or her merchandise and is expected to refund in full any money paid to the dealer by any customer for material sold that is contrary to this policy.
12. The Temple B’Nai Torah will not permit the sale, trade, or display of any material deemed to be unlicensed and/or unauthorized by Major League Baseball, the Players Association, including teams or individual players. This proscription applies to all other sports and non-sports material as well. The dealer is responsible for furnishing copies of licensing agreements and/or authorizations as may be requested by The Temple B’Nai Torah or licensing entities.
13. The Temple B’Nai Torah will not permit gambling devices, games of chance, slot machines, or any other activity defined primarily as gambling, at the show; no material considered offensive, lewd, and/or distasteful may be displayed or sold. Any materials deemed not appropriate for sale by The Temple B’Nai Torah must be removed immediately. Failure to comply may result in loss of booth rights and/or any applicable deposits or show rent.
14. Dealers will not bring current/former professional athletes as booth assistants or provide photographs/autographs at this show unless approved in writing by The Temple B’Nai Torah 30 days before the show.
15. Any form of solicitation for shows other than The Temple B’Nai Torah sponsored events is not permitted inside or outside of the show facility without prior written consent of The Temple B’Nai Torah. Violators are subject to removal from the property and the confiscation of any printed material contrary to this policy.
16. The dealer is responsible for providing all booth covers, lodging reservations, change, and transportation.
17. Security guards, contracted by The Temple B’Nai Torah, will be on duty throughout the show weekend.
18. No items may be attached or affixed to painted, papered, or wood surfaces in the facility.
19. All dealer booths must be closed promptly at the listed show closing times each day.
20. The Temple B’Nai Torah will notify the dealer of show set-up times and show hours before the show dates.
21. The Temple B’Nai Torah reserves the right to deny or cancel a booth rental or to not issue a dealer badge to any individual without providing a reason for the denial.
22. Neither The Temple B’Nai Torah nor The Temple B’Nai Torah, their owners, officers or employees, agents, and contractors are liable for stolen, lost, or damaged material, nor injury or loss to any person for any reason.
23. The Temple B’Nai Torah maintains the highest ethical standards, and if any information is received by The Temple B’Nai Torah that could affect its reputation, it shall have the right to refuse an application or cancel any contract in its sole discretion, and without providing a reason for said refusal or cancellation. The Temple B’Nai Torah shall not be held liable for any consequential damages as a result of said refusal or cancellation.
24. The Temple B’Nai Torah reserves the right to establish additional rules, policies, and procedures for the show as it deems proper and necessary. The dealer agrees to accept all rules, policies, and procedures established by The Temple B’Nai Torah.

25. The terms specified on this form are part of a legally binding agreement between the registered dealer named on the reverse side and The Temple B'Nai Torah. The dealer, through submission of this application form, agrees to abide by all show rules, policies, and procedures, and to accept the responsibility for compliance of the same by all members of his or her party throughout this contract.
